  - In the Operating Budget there is an intentional spend down of \$85,422. The funds will be used for paid leave and to attract new staff. We are also expecting a grant for \$20,000 to purchase new wheelchairs.
  - In Capital there is a pot of \$17,000 which we will continue to monitor for building items.
  - Special Revenue fund contains \$20,000 for scholarship expenses.
  - Long Range and Capital Expenditures has the replacement schedule for furniture and equipment.

## IX. STAFF REPORTS

- A. **Administration** Superintendent Natalie Principe reminded Board Members of the budget schedule with upcoming dates. The State grant application has been approved.
- B. Recreation Superintendent Jorie Meyer reported:
  - WDSRA continues to collaborate with LWSRA on Wheelchair basketball. Curtis Lease is a coach and the Varsity team is currently ranked 5<sup>th</sup> nationally.
  - Special Olympics Athletes participated in Winter Games in Galena with no snow.
  - Starting in February the Head Instructors in Rec & Roll will be getting more hours.

- On August 11 we will host a Family Fest at the Grand Pavilion in Naperville. This is a free event for families.
- We are collaborating with Little Friends Spectrum for programs.
- Timothy Christian students volunteered at Rec & Roll sites in January.
- Most of the Rec team went to conference and have a ton of takeaways.
- C. Staffing and Support Services Superintendent Tammy Kerrins reported:
  - Staff learned a lot at conference.
  - Fall Inclusion statistics have a 34% increase from 2022 covering 313 programs. We continue to grow and are on track for the largest year ever.
  - There is a new part-time 12-15 hour position for inclusion hiring. He has hired 14-15 people in a month.
  - Claire Cerny was hired and started last Thursday. Her towns are Bloomingdale, Roselle, Warrenville and Wheaton.
  - The level of collaboration and synergy with member park districts is very exciting. New people are responding to training requests.
- D. Communications and Development Superintendent Lea Jackman reported:
  - Annual Appeal is over with more than \$70,000 donated.
  - Bash: There are 408 registered so far assuming all sponsors use their tickets.
  - Partnerships: Franklin Middle School Dodgeball Tournament fund raiser has chosen WDSRA as a benefiting charity.
  - Grants: We are presenting to Hinsdale Junior Women's Club for \$20,000 for 5 sport wheelchairs.
  - FJK Foundation donated \$85,000 this year instead of their usual \$30,000.
  - First Trust increased donation by \$10,000 and may do the same going forward.
  - Naperville Rotary Club donated \$5,000 from Lights Parade fundraiser.
  - Publicity: Jackman highlighted Manschot's work getting our name out.

Wilson stated that it speaks a lot to relationships that have been built. Jackman said we have a very active Foundation Board that is a pleasure to work with.
