V. Budget 2024-2025 Presentation – Executive Direct Leahy and Superintendent Principe presented an overview of the 2024-2025 Budget, *Fluid, Adaptable & Resilient*. Topics included: Mission & Vision, Core Tenants of Strategic Plan, 2023-2025 Accomplishments, Operating Assumptions, Capital Assumptions, Revenue Sources, Member Tax Contribution split, Foundation Accomplishments, Possibilities Society, Expense Analysis, Fund Balance, and 24-25 Strategic Goals.

Rini asked about the IMRF unfunded liability and if excess funds could be used to spend it down. Potts asked about the retention limit which is 25% of operating expenses. Benard recommended looking at changing the retention to a range of 25% to 50% to reduce the amount of over policy levels. McAteer asked about investment income which is approximately \$120,000 this year. Wilson asked why there wasn't much budgeted for Capital improvements. Leahy explained that most of the work on the building will be coming out of this year's budget. If more funds are needed the Board can vote to transfer out of operating.
