IX. STAFF REPORTS

- A. **Recreation** Superintendent Jorie Meyer reported:
 - Camps are in full swing
 - Because the system was down for 3 weeks in May they were behind in finalizing registration. They are still working through the kinks but registration is at an all time high.
 - Spring games took place at the end of April. WDSRA had 23 athletes participating and 4 earned gold medals.
 - Rec & Roll survey results are in the packet. Parents are very happy and the Rec & Roll team is looking at implementing a few suggestions.
 - Athletics continues to grow with more programs. They now have a youth flag football with 15 volunteers from Naperville North High School helping out.
 - We are now partnering with Fry YMCA for swim lessons in the fall. Fountain View has also stepped up and we will have swim lessons there in the fall.
 - Our Day programs made flowers for the garden as part of the Roselle Passion project
 - A Rec & Roll field supervisor has been hired to assist the team with day-to-day operations
 - A Program Supervisor has left for another position and that position will be filled at the end of the summer.
- B. Inclusion and Risk Management Superintendent Tammy Kerrins reported:
 - The last bunch of camps started this week. The numbers are up 20% from last year with about 1700 for the summer
 - Thank you for the opportunity to train the Park District Camp staff.
 - There is an open Inclusion position that they will look to fill at the end of the summer. Meanwhile they have hired a part time person to do clerical work.
- **C.** Communications and Development Superintendent Lea Jackman reported:
 - The Golf outing was sold out for the 6th year in a row, including the expansion to an additional course. The net is around \$60,000 which includes a big contribution from a sponsor. Thank you to everyone for their support.
 - The Charlie Long award this year went to Joe Kish, whom Benard invited to golf with him and go to dinner.
 - Kristy Henson will be on maternity leave for 3 months.
 - We have had great success with grants and have received \$17,000 in the last 2 weeks.
 - Donations from the Franklin Middle School Dodgeball tournament are \$19,100.
 - The Endowment Contribution from the Medina 100 Women who care is at \$45,000 with the possibility of another \$5,000 grant in September.
